The Board of Supervisors voted to approve the rezoning.

The Planning Commission will hold a public hearing on [proposed amendments to the Roanoke County Zoning Ordinance](#) that would: amend application requirements, and time limitations in Sec. 30-19 Special Use Permits in Article I (General Provisions); add definitions for temporary construction yard and short-term rental, and amend the definition for home beauty/barber salon in Article II (Definitions and Use Types); add religious assembly as a permitted use in AG-3 Agricultural/Rural Preserve District, add commercial indoor amusement as a permitted use in C-2 High Intensity Commercial District, and add short-term rental as a permitted use in AG-3 Agricultural/Rural Preserve District, AG-1 Agricultural/Rural Low Density District, AR Agricultural/Residential District, AV Agricultural/Village Center District, R-1 Low Density Residential District, R-2 Medium Density Residential District, C-1 Low Intensity Commercial District, and C-2 High Intensity Commercial District in Article III (District Regulations); add use and design standards for short-term rental, and amend the use and design standards for home beauty/barber salon, and multi-family dwelling in Article IV (Use and Design Standards); and amend Sec. 30-100-2 dealing with yard, setback, coverage, and height requirements, and add a new section on temporary uses including standards for temporary construction yards in Article V (Development Standards). The proposed amendments would also amend various sections in Articles I, III, IV, and V changing "department of community development" to "department of development services" and/or "department of planning."

New CORTAN Provider

Starting January 12, 2021, Via is partnering with the Roanoke County CORTAN program to provide transportation services. Eligible riders are County residents who are at least 70 years of age, or those who have a disability.

Riders may continue to travel to destinations within Roanoke County, the Town of Vinton, the City of Roanoke and the City of Salem for \$5 per trip, Monday through Friday, between 7 a.m. and 6 p.m.

Upgrades to the CORTAN program include:

- Booking your rides through a mobile app, which lets you track your ride;
- New wheelchair-accessible Toyota Sienna minivans;
- New ways to pay for your ride; and
- Safety measures in accordance with social distancing guidelines.

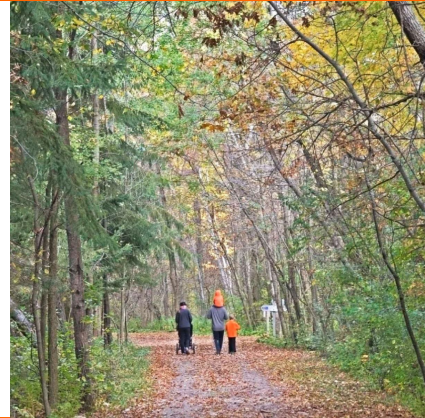

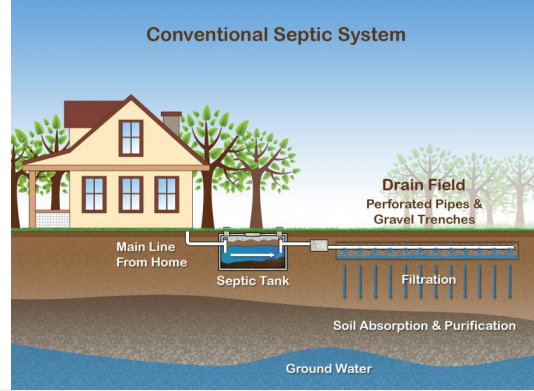
Flood Insurance: Myth or Fact?

MYTH: NFIP flood insurance does not cover basements.

FACT: Yes, it does, but coverage is limited. The NFIP defines a basement as any area of a building with a floor that is below the ground level, on all sides. Basement coverage under NFIP policy includes cleanup expenses and items used to service the building such as elevators, furnaces, water heaters, washers and dryers, air conditioners, freezers, utility connections, circuit breaker boxes, pumps, and tanks used in solar energy systems. The policy does not cover the contents or improvements such as finished walls, floors and ceilings.

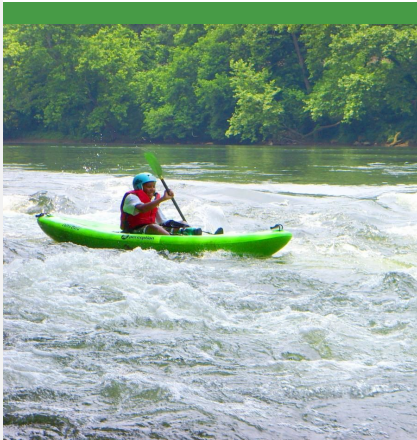

Oak Grove Center Plan Adopted

We are excited to announce that the Oak Grove Center Plan has been adopted by the Roanoke County Board of Supervisors and the City of Roanoke City Council!

Check out the easy-to-read [Plan Summary](#), which highlights the key components of the complete Plan (and Appendices) with graphics, maps, tables and charts.

The Plan will be implemented over the next 20-plus years. Successful implementation of the Plan depends on regulatory tools, continued community engagement and appropriate financing policies that can encourage and guide private development along with strategic public investment.



The plan recommendations are derived from public input and aim to provide a structure for implementation that will serve the health, safety, prosperity and welfare of the

Progress continues on the Route 419 Widening, Safety and Multimodal Improvements project.

The Kanawha Stone Company, Inc. is installing storm sewer and a water main along the Wendy's side of Route 419 and is currently working near Copper Croft Apartments. The shoulder will continue to be closed for construction activities but

entrances to the businesses are open. Crews are now operating overnight along the corridor as well, as weather permits.

The project will be complete by the end of this year and will include a third travel lane between Ogden Road and Route 220, sidewalks, bike lanes, pedestrian signals and crosswalks, and a bus shelter. For updates check the [Salem District Facebook](#) page or the VDOT [Salem Projects](#) website.

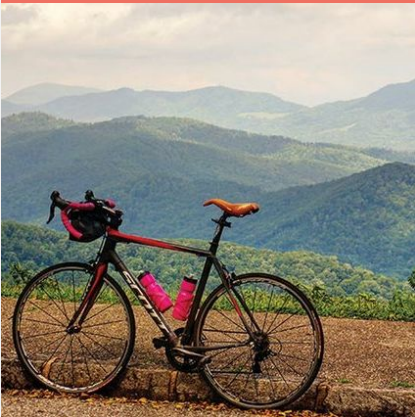
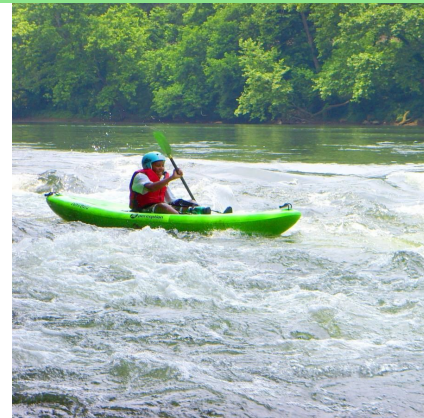

Moncap Trail Improvements



Moncap Trail is located in the Poage Farm area, not far from Route 221/Bent Mountain Road. The road was added to the Secondary Six-Year Plan in 2004 as a Rural Rustic project to reconstruct and surface treat the VDOT-maintained, 0.2-mile-long roadway, while also constructing a turnaround. Funds were steadily added to the project for several years and, when drainage easements were obtained from adjacent property owners, VDOT contractors completed the work earlier this year (before and after photos above). Thank you to the VDOT Salem Residency for improving this roadway.



Sidewalk Construction in Glenvar

The Glenvar Community Plan, adopted in 2012, included significant public feedback. The community indicated a strong desire for streetscape improvements along the entirety of West Main Street, to include bicycle lanes, sidewalks, community identification signs and landscaped medians.

Once the Route 11/460 Widening Project was complete, County staff applied for grant funding in 2015 and 2016 to construct sidewalks along West Main Street between the City of Salem and Technology Drive, the entrance to Roanoke County's Valley Tech Park. The grant applications were successful and VDOT has been administering the project. Virginia Infrastructure, Inc. from Lexington, Virginia, began construction activities in August. When complete, new sidewalk will extend from Alleghany Drive/Garman Road to Technology Drive along the south side of West Main Street. Pedestrian crosswalks and signals will also be installed at Alleghany Drive/Garman Road and at Daugherty Road.

Drivers in the area can expect lane closures and flagging operations between 9 a.m.

and 3 p.m., Monday through Friday. The project is anticipated to be complete in December 2021.



Slope Repair on Route 220 South

VDOT is repairing a slope along Route 220S near the intersection with Crossbow Circle. Heavy rains in recent years have caused this slope to move. The repairs entail removing about 1.5 acres of trees and debris, using soil nails to stabilize the slope and constructing a retaining wall at the base of the slope. Drivers can expect short-term lane closures with flaggers directing traffic. Work on the \$1.4 million project is expected to be completed this fall, weather permitting.

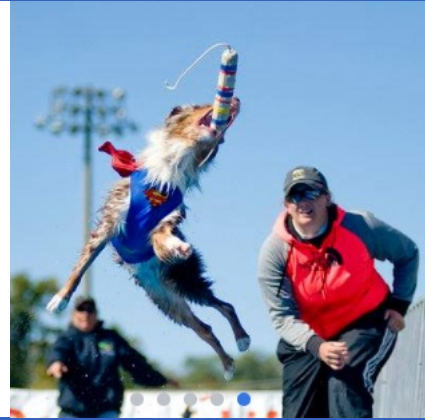

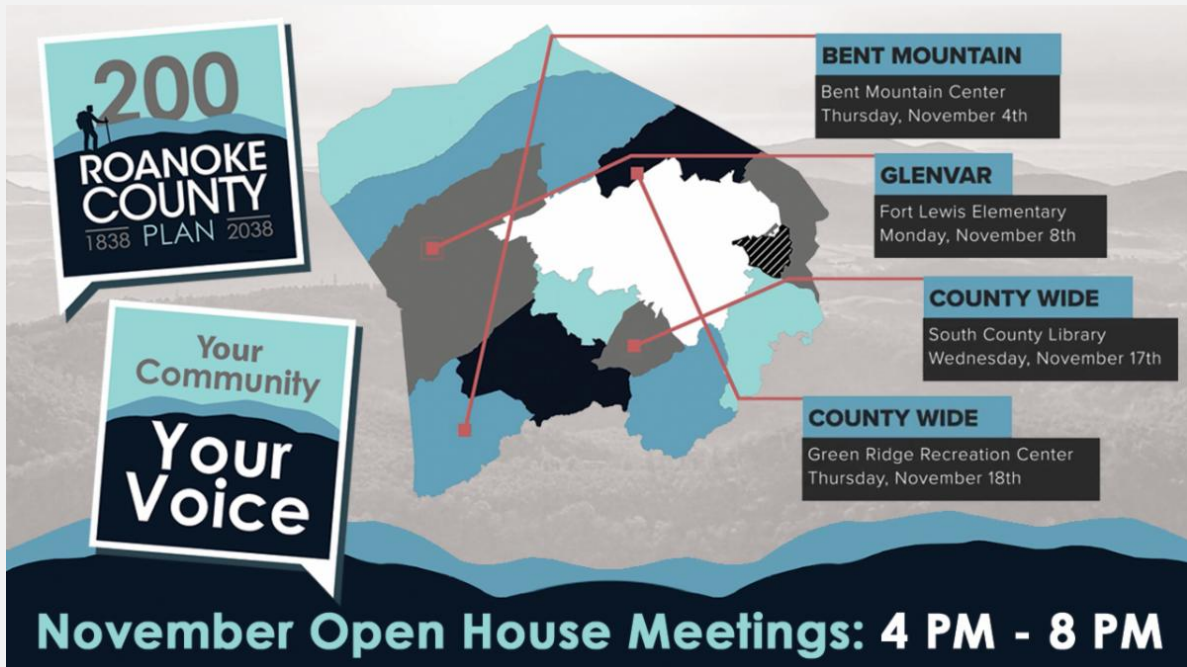
Fall Foliage Guidance
